

# Macomb/St. Clair Workforce Development Board Policy Issuance: Social Media Community Guidelines

**Purpose:** This policy provides guidance for establishing and maintaining public-

facing social media community standards for Macomb/St. Clair Michigan Works!. It defines how official social media platforms are monitored, how user-generated content is managed, and how public

interaction aligns with legal and organizational requirements.

**Background:** This policy applies to both Macomb/St. Clair Michigan Works! staff and

members of the public who engage with the organization through its

official social media accounts. Staff will refer to this policy when

managing or moderating social media platforms to ensure consistency and compliance, while the public may refer to it to understand how

comments and interactions are moderated.

**Policy:** Macomb/St. Clair Michigan Works! maintains official social media

accounts to share updates, success stories, and resources that support job seekers, employers, and community partners across Macomb and St. Clair counties. These accounts are used to advance our mission to connect talent and employers, strengthen communities, and promote

equitable pathways to prosperity.

We welcome public comments and discussion on our social media posts and encourage civil, accurate, and respectful engagement that aligns with these community guidelines. To support constructive dialogue, comments and user-generated content shared on our platforms are monitored and reviewed by the Macomb/St. Clair

Michigan Works! communications team.

For purposes of this policy, "social media" includes all content created by individuals, using accessible, expandable, and upgradable publishing technologies, through and on the Internet. For purposes of this policy, "comments" include information, articles, pictures, videos or any other form of communicative content posted on Macomb/St. Clair Michigan Works! social media sites or as online posts to articles or blogs. All Macomb/St. Clair Michigan Works! social media sites adhere to applicable federal, state and local laws, regulations and policies. Macomb/St. Clair Michigan Works! reserves the right to remove, hide, or restrict user-generated content or comments that include any of the following:

- The use of profanity, obscene, threatening, discriminatory, defamatory, or harassing language
- Personal attacks on individuals or groups, including targeting based on race, ethnicity, gender, religion, sexual orientation, or disability
- Disclosure of information that is confidential by law or regulation
- Comments that advocate for, incite, or promote intimidation or illegal activity or conduct
- Posts that infringe upon copyright or trademark protections
- Advertisements, solicitations, or promotions unrelated to Macomb/St. Clair Michigan Works! programs or workforce development initiatives
- Endorsement or opposition of any political candidate or ballot initiative
- Spam, irrelevant, repetitive, or automated content (including content generated by bots or automated software)
- Speech that infringes upon the First Amendment rights of others
- "Trolling" or posting content with the intent to provoke others or disrupt conversation
- Content that may compromise the safety, security, or privacy of individuals, systems, or infrastructure
- Content that misrepresents or falsely attributes actions, statements, or positions to Macomb/St. Clair Michigan Works! or its affiliates

Repeated violations of these guidelines may result in a user being blocked or restricted from interacting with our accounts.

## User-generated content: terms and conditions

By tagging, sharing, or submitting content to Macomb/St. Clair Michigan Works! for publication on our digital platforms, you confirm that:

- You are the creator of the content or possess the necessary rights and permissions to share it with us, and
- Sharing the content with Macomb/St. Clair Michigan Works! will not infringe upon or violate the rights of any third party

By submitting content, you grant Macomb/St. Clair Michigan Works! a nonexclusive, perpetual, royalty-free, worldwide license to use, edit, reproduce, publish, share, or otherwise distribute the content across our platforms and publications. You also agree not to use or distribute the same content in a manner that misrepresents or conflicts with its appearance on official Macomb/St. Clair Michigan Works! channels. All comments posted by members of the public on any Macomb/St. Clair Michigan Works! social media site are the opinions of the posters only.
